ARTICLES OF INCORPORATION

OF

TOWNE LAKE RESIDENTIAL OWNERS ASSOCIATION, INC.

Article 1. Name. The name of the corporation is

Towne Lake Residential Owners Association, Inc. ("Corporation"
or "Association").

Article 2. <u>Duration</u>. The Corporation shall have perpetual duration.

Article 3. Applicable Statute. The Corporation is organized pursuant to the provisions of the Georgia Nonprofit Corporation Code.

Article 4. <u>Purposes and Powers</u>. The Corporation does not contemplate pecuniary gain or profit, direct or indirect, to its members.

- (a) In way of explanation and not of limitation, the purposes for which it is formed are:
- which reference is made in the Master Declaration of Protective Covenants for Towne Lake Residential Area ("Declaration"). establishing a plan of development recorded in the office of the Clerk of the Superior Court of Cherokee County, Georgia, to perform all obligations and duties of the Association, and to exercise all rights and powers of the Association, as specified therein, in the By-Laws of Towne Lake Residential Owners Association, Inc. ("By-Laws"), and as provided by law; and

- (ii) to provide an entity for the furtherance of the interests of the owners of property subject to the Declaration (such property is hereinafter referred to as the "Development").
- (b) In furtherance of its purposes, the Corporation shall have the following powers, which, unless indicated otherwise by the Declaration or By-Laws, may be exercised by its board of directors:
- (i) all of the powers conferred upon nonprofit corporations by common law and the statutes of the State of Georgia in effect from time to time;
- (ii) all cf the powers necessary or desirable to perform the obligations and duties and to exercise the rights and powers set out in these Articles, the By-Laws, or the Declaration, including, without limitation, the following:
- (1) to fix and to collect assessments or other charges to be levied;
- (2) to manage, control, operate, maintain, repair, and improve property subjected to the Declaration or any other property for which the Corporation by rule, regulation, Declaration, or contract has a right or duty to provide such services;
- (3) to enforce covenants, conditions, or restrictions affecting any property to the extent the Association may be authorized to do so under the Declaration or By-Laws;

- (4) to engage in activities which will actively foster, promote, and advance the common interests of all owners within the Development;
- (5) to buy or otherwise acquire, sell, or otherwise dispose of, mortgage, or otherwise encumber, exchange, lease, hold, use, operate, and otherwise deal in and with real, personal, and mixed property of all kinds and any right or interest therein for any purpose of the Corporation;
- (6) to borrow money for any purpose as may be limited in the By-Laws;
- enforce contracts of every kind and description, and to do all other acts necessary, appropriate, or advisable in carrying out any purpose of the Association, with or in association with any other association, corporation, or other entity or agency, public or private;
- (8) to act as agent, trustee, or other representative of other corporations, firms, or individuals, and as such to advance the business or ownership interests in such corporations, firms, or individuals;
- (9) to adopt, alter, and amend or repeal such By-Laws as may be necessary or desirable for the proper management of the affairs of the Association; provided, however, such By-Laws may not be inconsistent with or contrary to any provisions of the Declaration; and

(10) to provide any and all supplemental municipal services as may be necessary or proper.

(11) The foregoing enumeration of powers shall not limit or restrict in any manner the exercise of other and further rights and powers which may now or hereafter be allowed or permitted by law; and the powers specified in each of the paragraphs of this Article 4 are independent powers, not to be restricted by reference to or inference from the terms of any other paragraph or provision of this Article 4.
